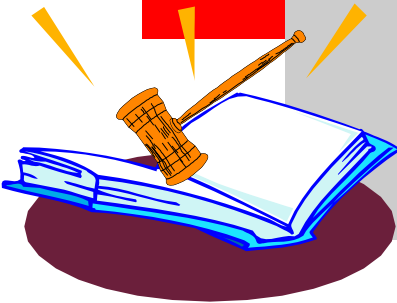


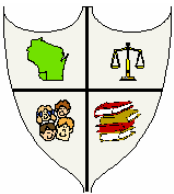
Fresh Start Program



NOTICE:
To avoid maximum penalties of your offense, it is crucial that you read and follow the procedures in this brochure.

Fresh Start is an alcohol and drug risk reduction program.

... that utilizes the Prime For Life, Under 21” curriculum which is a non-judgmental program for youth 13-20 who may be or are likely to engage in high risk drinking or drug use. It is a 12 hour program, typically divided into 3 hours, one night a week, for 4 weeks. “Prime For Life Under 21” focuses on the risks associated with alcohol use and how to lower those risks. It includes a student workbook, a self assessment, and individual and group learning activities. Thousands of youth throughout the country are taught the curriculum through juvenile justice systems, underage drinking programs and schools.

I hereby admit to the charge of consuming/possessing intoxicants. I agree to successfully complete the Fresh Start program by:

GUILTY PLEA AGREEMENT

1. *Attending all 12 hours of education.*
2. *Completing all assignments*
3. *Actively participating*
4. *Passing all tests with a 70% or better*
5. *If under 17, one parent must attend the 3rd night of class*
6. *Not re-offending within one year of completing the course or before turning 21 whichever occurs first*

If proof of successful completion is provided, this matter will be dismissed after one year if there are no other underage drinking offenses or until turning 21, whichever occurs first. I understand that if I re-offend within a year both citations will go to court, I will be required to pay both fines, and I will lose my operating privileges for a length of time determined by the judge.

I, the defendant, hereby consent to the above order, and agree to cooperate/participate in the program. If under 17, the undersigned parent(s)/guardian(s)) hereby consents to entry of the above order and agrees to cooperate/participate in the program.

If I choose to participate in the Fresh Start Program, I must do the following:

1. Register for the program within 10 days
2. Complete the course
 - Attend all 12 hours of class
 - Be on time and actively participate
 - Pass the tests with a 70% or better
 - Complete all assignments
3. If under 17, one parent/guardian must attend the 3rd night of class.
4. Do not re-offend
 - before class
 - during class
 - within one year of completing class

How to Register for the Program

1. Fill out the registration form completely with ALL blanks filled in and send it within 10 days of receiving citation.
2. Send money order, only, made out to Fresh Start, with registration form. (Personal checks will not be accepted)
 - 17-20 years old: \$150
 - Under 17: \$100
3. Sign guilty plea agreement on back of registration form.

I have 2 options

I can go to court which will result in a fine starting at \$150, loss of my license, and higher insurance rates.

OR



I can attend Grant County's Fresh Start Program

which upon successful completion:

- My ticket will be voided
- My license will not be suspended
- My insurance will not increase
- I will have better knowledge of risks, guidelines, trigger levels, and phases of alcohol use.

** If you received additional citations with your underage drinking citation, you cannot enroll in Fresh Start and all tickets will be sent to court. **
